**DECLARATION OF AGREEMENT TO THE CO-RESPONSIBILITY PACT FOR THE  
IMPLEMENTATION OF MEASURES AIMED AT THE PREVENTION OF COVID-19 INFECTIONS**

INTRODUCTION

As provided for in the Guideline and Guidance Document for the resumption of activities in presence of the educational services and the pre-schools for the school year 2020/2021 – approved with Ministerial Decree n. 80 of the 3<sup>rd</sup> of August 2020 – and in the Operational Protocols adopted by the Municipality of Bologna and published on the institutional website of the Authority, the relationship between the educational service or school and the family plays a key role, for their shared educational co-responsibility, in order to ensure compliance with the required safety conditions.

For this purpose the parents or holders of parental responsibility or guardians of the children attending the service must sign this Act of Agreement to the Co-responsibility Pact for the implementation of security measures provided for by Municipal Operational Protocol and its annexes in use in the pre-school for the year 2020/2021, and for a responsible, loyal and diligent collaboration.

The commitments the Municipality of Bologna assumes for the containment of infections from Covid-19 in management of 0/6 services for the school year 2020/2021 are indicated in the documents published on the website

and its annexes, containing the national and regional reference provisions for the definition of commitments set out in this document.

having read the Operational Protocol and the annexes to the pre-school and educational services 03 - year 2020/2021;

## STATES/STATE

*with reference to the child*

1. to comply with the requirements of vaccination related to the child enrolled in pre-school;
2. to be aware of the current contagion control measures;
3. that the child is not subject to a quarantine measurement or isolation for positivity to Covid-19 on the date of this declaration;
4. to actively monitor the child's health conditions and to keep him at home, simultaneously informing the pre-school if he shows significant symptoms - also in the previous three days - compatible with Covid-19:
  - temperature higher than 37,5°;
  - acute respiratory symptoms such as cough or rhinitis with breathing difficulties;
  - vomiting (repeated episodes accompanied by malaise);
  - diarrhea (three or more discharges with semi-liquid or liquid stools);
  - loss of taste (without cold);
  - loss of smell (without cold);
  - severe headache;
5. to be aware that the child will be discharged from the educational facility in the presence of the above symptoms during the stay at the pre-school and that these symptoms supplement those of the common contagious diseases that continue to be a reason for not attending educational services; to agree to this end to provide all telephone numbers for a timely availability and immediate removal of the child;
6. to undertake to respect the specific health protocol in the presence of symptomatology described above detected in the domestic or pre-school environment and in particular:
  - to contact the free choice pediatrician (PLS) who shall request the carrying out of the swab in accordance with the rules laid down by the competent ASL. In case of positivity the child will stay at home until resolution of symptoms and negative results of two swabs carried out at least 24 hours apart, following the instructions of the Department of Public Health (SDR) concerning readmission in the community. The child will then return to the community with a certificate of recovery of the DSP. In case of negativity, however, the PLS will produce a certificate for re-entry into the community once the symptoms are over, in which the negative result of the swab will be reported;
  - In case of a positive diagnosis in the child: to promptly provide the health authority with all information on the service attended by the child aimed at a rapid management of any cases and outbreaks from Covid-19 and to the tracing of the contacts from part of the DSP in collaboration with the city Covid referent;

- In case of a positive diagnosis in the child: to promptly inform the Covid referent's office by sending an appropriate email to [referentecovidscuolenidi@comune.bologna.it](mailto:referentecovidscuolenidi@comune.bologna.it); to send to the same email address [referentecovidscuolenidi@comune.bologna.it](mailto:referentecovidscuolenidi@comune.bologna.it) the certificate of recovery issued by the DSP so that the pre-school can be informed in advance of the return of the child. Copy of the certificate of recovery shall be presented also at the pre-school at the time of return.
- In case of symptoms not attributable to Covid-19: to follow the instructions of PLS, as normally happens, on the measures of treatment and times for the return of the child, directly informing the pre-school. In these cases no certificate is required for readmission.

7. to undertake not to take the child to the pre-school in case of contact with known Covid-19 cases during the previous 14 days;

8. to be aware and accept that the child will be subjected to the measurement of fever with non-contact thermometer before accessing to the pre-school and that, in case of temperature higher than 37,5°, he cannot be admitted to the facility;

9. to undertake to take precautionary measures with regard to the risk of contagion at all times and in all places outside of the school day;

*with regard to parents, other members of the household living with them and any other close contacts (e.g. accompanying persons)*

10. that the undersigned/s and other cohabiting partners within the household are not subjected to the measure of quarantine or isolation for positivity to Covid-19 to date of signature of this declaration;

11. to undertake to contact promptly, in the expected cases of suspected symptoms for themselves or for one of the cohabiting within the family, their own medical doctor general (MMG);

12. to undertake to keep the child in his home and not to send him to the pre-school in case of suspected Covid-19 infection of one of the cohabiting partners in the household;

13. to be aware and accept that, in the case of a parent positive to Covid-19, a cohabiting partners or other close contact (e.g. accompanying person), the child cannot be admitted to the service for the time and in compliance with the indications that will be given by health authorities and in particular in such cases:

- the pre-school should be informed promptly using the usual communication channels;
- the specific health protocol should be respected and be provided the informations requested by the health authority concerning the service attended from the child;
- before the return of the child it must be sent to the contact person Covid office a copy of the certificate issued by the competent health authority for the readmission of the child in the community;

14. to be aware that even any child's accompanying person cannot enter the pre-school in case of suspected infection with Covid-19 and the above situations and undertake to inform them accordingly;

15. to commit to the use of the mask for the entrance to the pre-school for himself and for other subjects of age more than 6 years;

16. to be adequately informed of all organisational and hygienic provisions for the safety and the containment of the risk of spreading the contagion from Covid-19 also with reference to the child and the provisions for access and exit the structure and to confirm the commitment to scrupulously comply with them;

17. to be aware and accept that for entry into the structure is provided the temperature measurement with non-contact thermometer for all subjects and that, in case of temperature higher than 37.5 °, you will not be able to access the pre-school;

18. to be aware that at the moment of a resumption of interaction activities, even if controlled, it is not possible to zero the risk of contagion that should be reduced to a minimum by scrupulous and strict observance of precautionary and safety measures provided for by the protocols in use for the performance of activities; for this it is important to observe maximum caution even outside the context of the pre-school;

It is specified that if the child is in close contact with a close contact (therefore not in direct contact with the Covid case) there is no precaution to take, unless the close contact of the case is subsequently positive for any diagnostic tests prescribed by the DSP; and that the latter has ascertained a possible exposure (as provided for in Report ISS COVID-19 n. 58/2020 Rev. - version of the 8<sup>th</sup> of August 2020).

The application of the health protocols provided for the management of cases and outbreaks of Covid is carried out in compliance with GDPR 2016/679 EU and the requirements of the guarantor. No data thus obtained will be disseminated and the municipality will provide all the appropriate information only to the authority competent health (DSP).
