

VIRTUAL DATA ROOM ADMISSION REGULATIONS IN RELATION TO BID FOR TENDER PROCEDURE FOR JOINT SALE OF SHARES HELD BY THE MUNICIPALITY OF BOLOGNA, THE PROVINCE OF BOLOGNA AND THE CHAMBER OF COMMERCE OF BOLOGNA IN THE COMPANY INTERPORTO BOLOGNA S.p.A.

The text are purely indicative. Only the Italian texts have legal value.

These Regulations govern the procedure for access to documents available in the Virtual Data Room in relation to the procedure for the sale of shares held by the Municipality of Bologna, the Province of Bologna and the Chamber of Commerce of Bologna in the company INTERPORTO BOLOGNA S.p.A.

Art. 1

The Virtual Data Room is available in electronic format at www.comune.bologna.it/concorsigare/ - 'Other public tenders and notices' section.

Interested users can access the Virtual Data Room after signing an admission application. The Virtual Data Room will be available on the Web via broadband connection.

Art. 2

Parties wishing too access the Virtual Data Room must send a request to the following email address: SegreteriaPartecipazioniSocietarie@comune.bologna.it by filling in an admission application form signed by the person requesting admission and/or by their legal representative according to the form attached to the bid for tender notice for the sale of shares in INTERPORTO BOLOGNA S.p.A. published on the website at www.comune.bologna.it/concorsigare/ - 'Other public tenders and notices' section, at www.provincia.bologna.it – "Tenders" section and at www.bo.camcom.gov.it/camera-di-commercio - "Tenders and competitions" section, accompanied by a copy of the applicant's identity document of their legal representative along with a copy of the present Regulations also signed for acceptance by the person requesting access and/or their legal representative.

Admission to the Virtual Data Room will be permitted subject to verification by the Municipality of Bologna compliant with the admission conditions and the truthfulness of the statements made. The Municipality of Bologna reserves the right to refuse, withdraw or suspend admission at its absolute discretion should it verify that it has occurred in violation of the rules laid down in the present Regulations.

Art. 3

Admission to the Virtual Data Room will be allowed only to duly authorized persons who will be sent an email with their user name and password required for admission.

When the authorized parties receive a username and password for admission to the Virtual Data Room, they will be able to access the available documents, subject to prior authentication.

Art. 4

The documents in the Virtual Data Room are in pdf format except for the case where the company may also upload documents into other formats.

Questions concerning documents in the Virtual Data Room must be submitted in the manner prescribed in the Bid for tender notice.

Should users have difficulty accessing the documents in the Virtual Data Room, they can contact the provider by clicking on the appropriate Technical Assistance Section.

The documents in the Virtual Data Room are confidential; therefore they can only be viewed and can not be copied, photographed, saved, removed, or changed in any way unless otherwise indicated.

Art. 5

While accessing the Virtual Data Room, each user shall not disclose to unauthorized third parties

the information contained in it ensuring that none of the documents or information can be viewed or made available to third parties.

Each authorized user shall not share their username or password with third parties; they shall log out whenever they have finished using the Virtual Data Room.

The Municipality of Bologna will be able to monitor the activities carried out within the Virtual Data Room by each user and keep logs of such activities.

Admission to the Virtual Data Room by each authorized user and its Representatives constitutes acceptance of all terms and conditions set forth in the present Regulations and in the Bid for tender notice.

Art. 6

Queries concerning clarification on the documents in the Virtual Data Room may be submitted, in Italian, no later than 12.00 p.m. on May 31, 2014 by sending an email to the email address:

Answers will be included in anonymous form in the Virtual Data Room in separate query files which will be constantly updated.
